Pursuant to open records law, I hereby request -- from Coffee County *and* its agents -- complete copies of the following records: any and all purchase orders, any and all purchase receipts, as well as any and all missing/lost/stolen form(s) for Misty Hampton's silver laptop pictured in security camera footage from February 22, 2021 (image attached).

My request is made for legitimate journalistic/news-gathering purposes pertinent to the ongoing nationwide reportage about Coffee County and its elections office.

I would like to receive the copies as soon as possible. I understand that according to Coffee County, if the records cannot be produced within three business days, a timetable for their release will be provided to me.

I understand that, pursuant to O.C.G.A. 50-18-71, I may be charged administrative and copying fees for the cost to search, retrieve, copy and supervise access to the requested documents. This fee represents the hourly rate of the lowest paid full-time employee with the necessary skill and training to respond to my request, with no charge for the first fifteen minutes that it takes to respond to the request. The charge for copies is generally \$.10 per page unless otherwise provided by law. I agree to pay all copying and/or administrative costs incurred with fulfilling my open records request.
